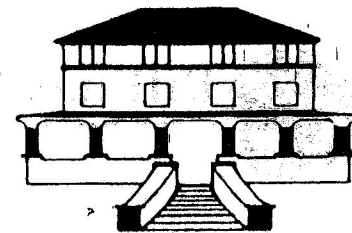

Muscle Testing Research June 1994

METHOD: A random selection of twenty-five (25) patients from the population of patients of Berks County Chiropractic Specialists, P.C., was muscle tested in a double blind manner.

The muscle testing utilized an "active" Bioelectric Shield and a "blank", paper, placebo shield. The muscle testing was performed in a manner consistent with standard Applied Kinesiology practice in that the muscle was initially tested to determine if it was "weak", and then it was re-tested with the placebo shield and then tested again with the "active" Shield. At the time of testing, both the placebo and the "active" Shield were placed on the patient's pericardial alarm point, CV 15.

Later, the patient's muscle was tested again utilizing a clock and then re-tested utilizing a clock and the "active" Shield.

If during any of the testing procedures, a muscle became stronger, it was noted as a positive change, and marked +. If during any of the testing procedures the muscle remained weak, it was noted as a negative change, and marked -.

CONCLUSION: The results of all testing procedures demonstrated a marked "positive" change in the muscle tested with the active Bioelectric Shield. This significantly demonstrated that the Bioelectric Shield strengthened an already "weak" muscle.
